#### RESOLUTION

(Seneca Dairy Systems LLC Project)

A meeting of the Seneca County Industrial Development Agency was convened on June 6, 2019.

The following resolution was duly offered and seconded, to wit:

Resolution No. 2019 - 16

RESOLUTION OF THE SENECA COUNTY INDUSTRIAL DEVELOPMENT AGENCY DECLARING ITSELF LEAD AGENCY WITH RESPECT TO THE REVIEW OF A CERTAIN PROJECT DESCRIBED IN THE APPLICATION OF SENECA DAIRY SYSTEMS LLC DATED APRIL 25, 2019

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 63 of the Laws of 1972 of the State of New York, as amended (hereinafter collectively called the "Act"), the **SENECA COUNTY INDUSTRIAL DEVELOPMENT AGENCY** (hereinafter called "Agency") was created with the authority and power to own, lease and sell property for the purpose of, among other things, acquiring, constructing and equipping civic, industrial, manufacturing and commercial facilities as authorized by the Act; and

WHEREAS, **SENECA DAIRY SYSTEMS LLC**, a New York limited liability company, for itself or on behalf of an entity to be formed by it or on its behalf (the "Company") has submitted an application (the "Application"), a copy of which is on file with the Agency, requesting the Agency's assistance with respect to a certain project (the "Project") consisting of: (i) the acquisition of an interest in approximately seventy-five (75) acres within the former Seneca Army Depot situated south of former County Road 135 and west of the former Fayette Street (the "Land"), (ii) the phased construction on the Land of approximately 223,000 square feet of manufacturing and warehousing facilities, an office complex and related amenities (collectively, the "Improvements"), and (iii) the acquisition and installation by the Company in and around the Improvements of certain items of equipment and other tangible personal property (the "Equipment" and, collectively with the Land and the Improvements, the "Facility"); and

WHEREAS, pursuant to the New York State Environmental Quality Review Act, Article 8 of the Environmental Conservation Law and the regulations adopted pursuant thereto at 6 N.Y.C.R.R. Part 617, as amended (collectively referred to as "SEQRA"), the Agency must satisfy the applicable requirements set forth in SEQRA, as necessary, prior to making a final determination whether to assist the Project; and

WHEREAS, with the Application the Company has submitted to the Agency a completed Part 1 of the Full Environmental Assessment Form ("EAF") in the form required by SEQRA, with supporting materials, including an Analysis of Environmental Impacts ("EA") (together with the

WHEREAS, based upon the Application and the Environmental Documentation, the Agency has (i) determined that the Project constitutes a "Type I Action" under SEQRA, pursuant to 6 N.Y.C.R.R. 617.4(b)(6)(i), as it involves the physical alteration of more than ten (10) acres and (ii) identified the parties listed on Exhibit A attached hereto as potentially "interested and involved agencies" under SEQRA (collectively, the "Potentially Interested and Involved Agencies"); and

WHEREAS, by Resolution adopted May 2, 2019, the Agency accepted the Application and declared its intent to act as lead agency for purposes of a coordinated review of the Project with all identified Potentially Interested and Involved Agencies pursuant to SEQRA; and

WHEREAS, on or before May 3, 2019 the Agency caused to be delivered to the Potentially Interested and Involved Agencies copies of the Application and the Environmental Documentation, together with notice of the Agency's intent to act as lead agency for a coordinated review of the Project pursuant to SEQRA (collectively, the "SEQRA Notice"); and

WHEREAS, none of the Potentially Interested and Involved Agencies have objected to the Agency acting as lead agency for a coordinated review of the Project pursuant to SEQRA, and the time period for an Involved Agency to object has expired.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE SENECA COUNTY INDUSTRIAL AGENCY AS FOLLOWS:

- Section 1. The Agency hereby adopts as findings the recitations above.
- <u>Section 2</u>. The Agency hereby declares itself lead agency for purposes of a coordinated review of the Project pursuant to SEQRA.
- Section 3. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions. Without limiting the foregoing, the officers, employees and agents of the Agency are authorized and directed to conduct a coordinated review of the Project under SEQRA and to retain engineering and other professional consultants as shall be necessary to facilitate the SEQRA review.

<u>Section 4.</u> This Resolution shall take effect immediately.
