

Brief Description of Proposed Action:  Sessler Wrecking is proposing to expand their office their facility in Waterloo, New York. The expansion consists of a 10,192 square feet two story addition (each floor 5,096 square feet) to the existing office building. The existing office building is 10,058 square feet (each floor 5,029 square feet). Site improvements are also planned to integrate the new addition and to provide additional parking/access to the lower level. The new parking lot will be connected to the existing lot but also accessible via a new entrance drive off State Route 96. The existing East parcel boundary requires modification to accommodate the new parking lot, entrance drive and new septic system. Both parcels are currently owned by the same entity (Sessler Wrecking/3S Gateway LLC). The new septic system will replace the existing septic system which is impacted by the new drive and parking lot.
